1. Purpose

The Artist agrees to create the artwork described herein for the Client, and the Client agrees to purchase the artwork under the terms specified in this Agreement.

2. Delivery and Acceptance

The Artist shall complete the Artwork by the agreed completion date. The Client shall have the right to inspect and accept the Artwork upon delivery. Acceptance shall not be unreasonably withheld.

3. Ownership and Copyright

Ownership of the physical Artwork shall transfer to the Client upon full payment. The Artist retains all copyrights, including reproduction rights, unless otherwise agreed in writing.

4. License

The Artist grants the Client a non-exclusive, non-transferable license to display the Artwork for personal or commercial use as specified in this Agreement.

5. Payment

The Client shall pay the Total Fee in accordance with the Payment Schedule. Late payments shall incur interest at the

maximum rate permitted by law.

6. Cancellation

Either party may terminate this Agreement upon written notice. If terminated, the Client shall pay for all work completed to date, and the Artist shall retain rights to all unfinished work.

7. Warranties and Representations

The Artist represents that the Artwork is original and does not infringe upon any third-party rights. The Client warrants the payment obligations herein.

8. Indemnification

Each party agrees to indemnify and hold harmless the other from any claims or damages arising out of breach of this Agreement.

9. Confidentiality

The parties agree to keep all proprietary information confidential and not disclose it to third parties without prior written consent.

10. Governing Law and Venue

This Agreement shall be governed by the laws of the State of _____. The parties consent to exclusive jurisdiction in the courts located in _____ County, _____.

11. Entire Agreement

This Agreement constitutes the entire agreement between the parties and supersedes all prior agreements. Amendments must be in writing and signed by both parties.

12. Force Majeure

Neither party shall be liable for failure to perform due to causes beyond their reasonable control such as natural disasters, acts of government, or other force majeure events.

13. Independent Contractor

The Artist is an independent contractor and not an employee, partner, or agent of the Client.

14. Notices

All notices must be in writing and delivered by hand, certified mail, or electronic means confirming receipt.

15. Severability

If any provision is found invalid, the remainder shall remain in full force.

16. Waiver

Failure to enforce any provision shall not constitute a waiver of future enforcement.

17. Assignment

Neither party may assign this Agreement without prior written consent.

18. Signatures

This Agreement may be executed in counterparts and via electronic signatures, all of which together constitute one agreement.

19. Dispute Resolution

The parties agree to attempt resolution through mediation before pursuing litigation.

20. Remedies

The rights and remedies provided herein are cumulative and not exclusive.
