1. Agreement to Sell and Purchase

Seller agrees to sell, and Buyer agrees to purchase, the goods described above (the “Goods”) on the terms set forth in this Agreement.

2. Condition of Goods

The Goods are sold AS-IS, WHERE-IS, without warranties of any kind except as expressly stated in this Agreement. Buyer acknowledges having the opportunity to inspect the Goods prior to purchase.

3. Delivery

Delivery of the Goods shall be made at the location specified by the Buyer, with risk and title transferring upon delivery unless otherwise agreed.

4. Payment

Buyer agrees to pay the Purchase Price in accordance with the Payment Terms stated above. Late payments may be subject to interest at the highest rate permitted by applicable law.

5. Representations and Warranties

Seller represents that it has good and marketable title to the Goods, free and clear of any liens or encumbrances, and that

it has full authority to enter into this Agreement.

6. Inspection and Acceptance

Buyer shall inspect the Goods upon delivery and may reject any items not conforming to this Agreement within a reasonable time frame.

7. Risk of Loss

Risk of loss or damage to the Goods passes to Buyer upon delivery at the agreed location.

8. Default

If either party fails to perform any material obligation under this Agreement, the non-defaulting party may seek all remedies available at law or in equity.

9. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the State of _____ without regard to conflict of laws principles.

10. Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes all prior negotiations, agreements, or understandings, whether written or oral.

11. Amendments

Any amendments to this Agreement must be made in writing and signed by both parties.

12. Notices

All notices under this Agreement shall be in writing and delivered personally, by certified mail, or by a nationally recognized overnight courier service to the addresses of the parties.

13. Severability

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.

14. Waiver

Failure to enforce any provision of this Agreement shall not constitute a waiver of future enforcement of that or any other provision.

15. Counterparts

This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

16. Binding Effect

This Agreement shall be binding upon and inure to the benefit of the parties and their respective successors and permitted assigns.

17. Assignment

Neither party may assign its rights or delegate its duties under this Agreement without the prior written consent of the other party.

18. Force Majeure

Neither party shall be liable for failure to perform due to causes beyond their reasonable control, including acts of God,

war, or governmental action.

19. Confidentiality

The parties agree to keep the terms of this Agreement confidential except as required by law or agreed in writing.

20. Signatures

The parties have executed this Agreement as of the date first written above.
