Cancellation Policy:

Client may cancel the event by providing written notice to Service Provider. Deposits are non-refundable unless cancellation is made at least 14 days prior to the event date. If cancellation occurs less than 14 days before the event, Client is responsible for the full agreement amount.

Service Provider's Obligations:

Service Provider shall provide all food, beverages, equipment, and staff necessary to perform the catering services described herein. Service Provider shall comply with all applicable health and safety regulations and maintain all required permits and licenses.

Client's Obligations:

Client shall provide access to the event location and necessary utilities (electricity, water) as reasonably required by Service Provider. Client shall ensure that attendees comply with any reasonable rules established by Service Provider during the event.

Indemnification:

Each party agrees to indemnify, defend, and hold harmless the other party and its officers, employees, and agents from and against any and all claims, damages, liabilities, costs, and expenses (including reasonable attorneys' fees) arising out of or related to the indemnifying party's negligence, willful misconduct, or breach of this Agreement.

Limitation of Liability:

In no event shall either party be liable to the other for any indirect, incidental, consequential, special, or punitive damages arising out of or relating to this Agreement, even if advised of the possibility of such damages. The total liability of either party for any claim arising under this Agreement shall not exceed the total fees paid by Client to Service Provider hereunder.

Force Majeure:

Neither party shall be liable for any failure or delay in performance due to causes beyond its reasonable control, including, but not limited to, acts of God, war, terrorism, civil disturbance, strikes, labor disputes, governmental actions, pandemics, or natural disasters.

Independent Contractor:

Service Provider is an independent contractor and is not an employee, agent, partner, or joint venturer of Client. Service Provider shall have no authority to bind or obligate Client in any manner.

Confidentiality:

Each party agrees to keep confidential and not disclose to any third party any confidential information received from the other party, except as required by law or as necessary to perform its obligations under this Agreement.

Governing Law and Venue:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to its conflict of law principles. The parties consent to the exclusive jurisdiction and venue of the state and federal courts located in _____ County, _____.

Dispute Resolution:

Any dispute arising out of or relating to this Agreement shall first be attempted to be resolved through good faith negotiations between the parties. If resolution cannot be reached, the dispute shall be resolved through binding arbitration administered in accordance with the rules of the American Arbitration Association.

Entire Agreement; Amendments:

This Agreement constitutes the entire agreement between the parties regarding the subject matter herein and supersedes all prior or contemporaneous agreements, understandings, and representations. Any amendments or modifications must be in writing and signed by both parties.

Severability:

If any provision of this Agreement is held to be invalid, illegal, or unenforceable, the remaining provisions shall remain in full force and effect.

Waiver:

The failure of either party to enforce any right or provision of this Agreement shall not constitute a waiver of such right or provision unless acknowledged and agreed to in writing.
