1. Engagement:

Client hereby engages Consultant, and Consultant agrees to provide consulting services as set forth in this Agreement on the terms and conditions herein.

2. Services:

Consultant shall perform the services described in Exhibit A attached hereto or as otherwise mutually agreed upon in writing by the parties.

3. Compensation:

Client shall pay Consultant the fees set forth in Exhibit B attached hereto, payable in accordance with the schedule therein. Consultant shall submit invoices and Client shall pay undisputed amounts within 30 days.

4. Term and Termination:

This Agreement shall commence on the Effective Date and continue until terminated by either party upon 30 days' prior written notice. Termination shall not relieve Client of obligation to pay for services rendered prior to termination.

5. Independent Contractor:

Consultant is an independent contractor and not an employee of Client. Consultant shall have no authority to bind Client or incur obligations on Client's behalf except as expressly authorized in writing.

6. Confidentiality:

Each party agrees to keep confidential all proprietary or confidential information disclosed by the other party in connection with this Agreement and to use such information solely to perform under this Agreement.

7. Intellectual Property:

All work product created by Consultant pursuant to this Agreement shall be the sole and exclusive property of Client. Consultant hereby assigns all rights, title, and interest in such work product to Client.

8. Indemnification:

Consultant shall indemnify and hold harmless Client from any claims, damages, liabilities, costs, and expenses arising out of Consultant's gross negligence or willful misconduct in performing services under this Agreement.

9. Limitation of Liability:

In no event shall either party be liable to the other for any indirect, incidental, consequential, special, punitive, or exemplary damages arising out of or related to this Agreement.

10. Governing Law and Venue:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to its conflict of laws principles. The parties consent to the exclusive jurisdiction and venue of the state and federal courts located in _____ County, _____.

11. Entire Agreement:

This Agreement, including all Exhibits, constitutes the entire agreement between the parties regarding the subject matter hereof and supersedes all prior agreements, understandings, and negotiations, whether oral or written.

12. Amendments:

Any amendments or modifications to this Agreement must be made in writing and signed by authorized representatives of both parties.

13. Notices:

All notices and communications under this Agreement shall be in writing and deemed given upon delivery by hand, certified mail (return receipt requested), nationally recognized overnight courier, or email transmission accompanied by confirmation.

14. Severability:

If any provision of this Agreement is found to be invalid or unenforceable, the remainder of this Agreement shall remain in full force and effect.

15. Waiver:

Failure to enforce any provision of this Agreement shall not constitute a waiver of that provision or any other provision.
