Custody Terms and Conditions:

1. Owner hereby grants Custodian temporary custody of the above-described pet (the "Pet") under the terms and conditions set forth herein. Custodian agrees to care for the Pet in a responsible and humane manner, providing adequate food, water, shelter, exercise, and veterinary care.
2. Custodian shall not transfer ownership or custody of the Pet to any third party without prior written consent of the Owner. Custodian shall notify Owner immediately of any illness, injury, or emergency affecting the Pet.
3. Owner shall remain the legal owner of the Pet at all times and retains all rights, including the right to reclaim the Pet upon reasonable notice. Custodian agrees to return the Pet to Owner upon Owner's request or at the termination of this Agreement.
4. Custodian shall exercise reasonable care for the Pet but shall not be liable for any illness, injury, or death of the Pet except as resulting from Custodian's gross negligence or willful misconduct.
5. Owner shall provide Custodian with all necessary supplies, medications, and instructions required for the proper care of the Pet during the custody period.
6. This Agreement shall remain in effect until terminated by either party upon reasonable written notice to the other, or upon return of the Pet to the Owner.

Fees and Expenses:

Owner agrees to pay Custodian the sum of _____ USD for the custody services rendered herein.

Payment shall be made as follows: _____.

Owner shall be responsible for any additional expenses incurred for veterinary care, medications, or other necessary expenditures exceeding the agreed fees, with prior notification and consent.

Indemnification and Liability:

Owner agrees to indemnify, defend, and hold harmless Custodian from any and all claims, damages, liabilities, costs, and expenses arising out of or related to the ownership or custody of the Pet, except to the extent caused by Custodian's gross negligence or willful misconduct.

Custodian shall not be liable for any indirect, special, incidental, or consequential damages arising from this Agreement.

Termination:

This Agreement may be terminated by either party upon reasonable written notice. Upon termination, Custodian shall return the Pet and any remaining supplies to Owner promptly.

Governing Law and Jurisdiction:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to its conflict of laws principles. The parties consent to the exclusive jurisdiction and venue of the state or federal courts located in _____ County, _____.

Miscellaneous:

1. Entire Agreement: This document constitutes the entire agreement between Owner and Custodian regarding the Pet custody and supersedes all prior understandings.
2. Amendments: Any amendments must be in writing and signed by both parties.
3. Severability: If any provision is held unenforceable, the remainder shall remain in full effect.
4. Counterparts: This Agreement may be executed in counterparts, each deemed an original.
5. Notices: All notices shall be in writing and delivered personally, by certified mail, or by electronic means.
