Clause 1 – Agreement to Sell and Purchase

Seller agrees to sell and Buyer agrees to purchase the equipment described above upon the terms and conditions contained herein.

Clause 2 – Condition of Equipment

The equipment is sold AS-IS, WHERE-IS, with all faults, and without any warranties, express or implied, including but not limited to warranties of merchantability or fitness for a particular purpose.

Clause 3 – Inspection and Acceptance

Buyer acknowledges the opportunity to inspect the equipment prior to purchase and accepts the equipment in its current condition.

Clause 4 – Payment

Buyer shall pay the full Purchase Price in the manner and schedule agreed upon above. Title and risk of loss transfer upon Seller's receipt of full payment.

Clause 5 – Delivery

Seller shall make the equipment available for pickup or delivery at the agreed location. Buyer is responsible for all costs and risks associated with transportation unless otherwise agreed.

Clause 6 – Title and Ownership

Seller warrants good and marketable title to the equipment, free of liens and encumbrances, and will transfer such title to Buyer upon payment.

Clause 7 – Taxes and Fees

Buyer is responsible for all applicable taxes, fees, and costs associated with the purchase, transfer, registration, or use of the equipment.

Clause 8 – Indemnification

Buyer agrees to indemnify and hold Seller harmless from any claims, damages, or liabilities arising after transfer of ownership.

Clause 9 – Default and Remedies

In the event of Buyer's default, Seller may retain any payments as liquidated damages and pursue all remedies available under law.

Clause 10 – Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to conflicts of law principles.

Clause 11 – Entire Agreement

This Agreement constitutes the entire understanding between the parties relating to the sale of the equipment and supersedes all prior negotiations and agreements.

Clause 12 – Amendments

Any amendment or modification to this Agreement must be in writing and signed by both parties.

Clause 13 – Notices

All notices under this Agreement shall be in writing and delivered in person, by certified mail, overnight courier, or electronic means with confirmation of receipt.

Clause 14 – Severability

If any provision of this Agreement is held invalid or unenforceable, the remaining provisions shall remain in full force and effect.

Clause 15 – Counterparts

This Agreement may be executed in counterparts, each of which shall be deemed an original, and all such counterparts shall constitute one agreement.

Clause 16 – Signatures

The parties have executed this Agreement by their duly authorized representatives as of the date first written above.
